Sir/Madam,

With reference to the subject cited above, I would like to inform you that the B.Ed. deputation for the year 2024-26 in different Government B.Ed. Colleges under different Universities of Assam will begin from June, 2024.

You are, therefore, requested kindly to furnish (Hard and Soft copy) of the list of maximum **30 teachers** working in Govt & Provincialised Schools under your jurisdiction, who are willing to undergo B.Ed deputation, in a prescribed format enclosed herewith.

- ➤ Institutions from where teachers have already been deputed for B. Ed Course for the session 2023-25, nominations of teacher from such Institution should be sent for deputation for the session 2024-26.
- ➤ Those, teachers who are willing to undergo the B.Ed course through ODL mode can take admission in the NCTE recognized institutions as notified vide Govt. letter dated: 21/02/2022 subjected to availability of study centre in the state of Assam by following the rules fixed by the Govt.
- ➤ In order to avoid any legal issues, it is mandatory to furnish the SENIORITY LISTof teaching staff of the school duly signed by the D.D.O. concerned and countersigned by the Inspector of Schools from where teachers are applying for B. Ed. deputation.
- Senior teachers must be given priority at the time of selection. If a junior teacher applies for B. Ed deputation, "No Objection Certificate" should be furnished by the senior teacher from the concerned Institution in a prescribed format.
- ➤ Teacher must fulfill the requisite qualification as per the NCTE / University norms. Only 1(one) teacher from each category of Post Graduate Teacher and Graduate Teacher should be selected from a school.
- ➤ Teacher from newly Provincialised schools may also apply for the B. Ed deputation. The documents shall be scrutinized for consideration by this Directorate as per provision in force.
- ➤ The deputation to undergo B.Ed training shall be given only one time in the career. In case, a teacher fail to pass the B.Ed examination in one attempt, he/she will not be considered for deputation for another term.
- Final list and placement of deputation of the selected candidates shall be made randomly by this Directorate subject to the availability of seat. No teacher can claim for accommodation in their home district as the seat capacity has been reduced in many Govt. institutions. However, this Directorate will try to make suitable arrangement as much as possible.

The list of teachers in a single proposal should reach this Directorate on or before 20/05/2024 without fail. No piecemeal manner proposal shall be accepted.

No proposal will be accepted after the specified deadline.

No further reminder for this purpose will be issued from this end .

While recommending the Name of Teachers the following points must be followed:

- 1. The Post Graduate Teacher and Graduate Teacher of both Government and Provincialised Secondary Schools who have completed at least 5 years of continuous regular service and the remaining length of service for PGT & GT is not less than 5 years shall be considered to undergo B.Ed. deputation in Government B.Ed. colleges in the State. In case of Tutors of the newly provincialised schools, the remaining length of service should not be less than 3 years for B. Ed deputation.
- 2. The payment of salary, grant of leave for the period of deputation etc, will be as per State Government rules in force .
- 3. Incumbents appointed to the post of the Post Graduate Teacher, Graduate Teacher in Govt./ Provincialised Secondary Schools with relaxation of professional qualification of B.Ed. degree as per Government Notification No.ASE.324/2009/138 dtd.13/09/2012 may pursue B.Ed. degree from the B.Ed. Colleges in the State which have affiliation from NCTE recognized universities in the evening shift classes without hampering the normal classes of the school. A prior permission from the competent authority shall be required for these teachers as per Rule 13 of "The Assam Civil Services (Conduct) Rule 1965". The competent authority shall grant leave to enable such teachers to appear in the examination, practical classes etc.
- 4. It is mandatory to circulate this letter to all the schools under your jurisdiction.
