**ORDER**

In pursuance of the Govt. letter No. E. 216757/226 dated 04-07-2023 and in exercise of the authority conferred under provision 7 (1) of the Assam Education (Provincialisation of services of Teachers and re-organisation of Educational Institutions) Act, 2017 & Amended Act, 2018, the services of the following 01 (One) Tutor of **Bongaigaon** District is hereby up-graded to the post of Teacher w.e.f the date shown against his name:

The Terms and conditions of service are as follows:-

1. This has the concurrence of Finance (EC-III) Departments vide EO No. 216757/254102/2023/6 dated 20/05/2023.
2. This is issued as per the "CORRIGENDUM" issued vide this office No. I/198344/2023, dated 17-06-2023 as per Govt. approval communicated vide No.E-306687,DSE-17013/26/2023-PLAN-dated 08.06.2023, wherein it is stated that "*Any Tutor who has already acquired the qualification required as per NCTE guidelines and Service Rules in force on or before the date of issue of his/her service Provincialisation order as Tutor shall be entitled to pay and allowances of a Teacher from the date of issue of such Provincialisation order as Tutor. Further, provided that the Tutors who acquires such qualification within 5 (five) years from the date of issue of his/her service Provincialisation order as Tutor shall also be entitled to pay and allowances equivalent to Teachers with effect from the date of issue of the Govt. approval on acquiring requisite qualification*".
3. As per Rule 21(I) of Assam Education (Provincialisation of services of Teachers and Re-Organisation of Educational Institutions) Act, 2017 the post shall be personal to the incumbent and the post shall stand abolished on cessation of the service of the teacher for any reason whatsoever including retirement, resignation, death etc.
4. The up-graded employee has to furnish a self declared affidavit in Court Stamp and undertaking.
5. In case of any document/certificate produced by the Tutor being found to be false at any point of time, his/her service shall be de-provincialised forthwith and legal action will also be taken as per law.
6. The up-graded employee will have to furnish an undertaking as prescribed by the Finance (Budget) Department vide its letter No.BW.3/2003/Pt./11/1, dated 25-01-2005 accepting the policy of introduction of "**New Pension Scheme**" 2005.
