Further, provided that the Tutors who acquires such qualification within 5 (five) years from the date of issue of his/her service Provincialisation order as Tutor shall also be entitled to pay and allowances equivalent to Teachers with effect from the date of issue of the Govt. approval on acquiring requisite qualification".

As per Rule 21(I) of Assam Education (Provincialisation of services of Teachers and Re-Organisation of Educational Institutions) Act, 2017 the post shall be personal to the incumbent and the post shall stand abolished on cessation of the service of the teacher for any reason whatsoever including retirement, resignation, death etc.
